We hope that each of you have survived Covid-19 and the Stay-at-Home orders in your area.



GUIDELINES FOR AMENDMENTS TO THE CONSTITUTION, RITUAL, BYLAWS, RULES and REGULATIONS, AND BOOK OF INSTRUCTION

SUBMISSION DATE GUIDELINES FOR THE FIFTIETH (50th) ASSEMBLY IN SALT LAKE CITY, UTAH

Guidelines for the dates for submission and distribution of the <u>Resolutions</u> for the 50^h Assembly to be held in Salt Lake City, Utah on November 1, 2021 through November 4, 2021 are established in the General Grand Chapter Preamble, Constitution, By-Laws, Rules and Regulations, and Book of Instruction, commonly referred to as the Red Book. Specific citations from the <u>2018 Edition</u> are as follows:

Article XV. in the Constitution;

Chapters X. and XI. in the Bylaws for the Ritual;

Chapter XII. in the Bylaws for the Parliamentary Authority;

Chapter XIII. in the Bylaws for the Bylaws;

Section 92 in the Rules and Regulations for the Rules and Regulations;

And the Amendments; Amendments, Alterations and Additions in the Book of Instruction for the Book of Instruction.

Please review these items for complete information regarding the Guidelines and the processes for the submission of Resolutions for consideration.

Sample Resolution for the 50th Assembly in 2021 Salt Lake City, Utah

Format below may be used or Resolutions may be drawn up according to Robert's Rules so long as they are perfectly clear and contain all the pertinent information.

Begin with a Statement of the Purpose of the Resolution:

CONSTITUTION of the General Grand Chapter, Order of the Eastern Star®, Article VII, POWERS OF GENERAL GRAND CHAPTER, (d), page 15

Current Wording Portion:

Which now reads:

(d) It shall be the exclusive judge of the qualifications of its own members, shall prescribe and determine the qualifications for membership in the Order, and shall prescribe and determine the Official Dues Receipts for all members in the Order. (AM 1982) (AM 2009)

New Wording Portion:

Be changed to read:

(d) It shall be the exclusive judge of the qualifications of its own members, shall prescribe and determine the qualifications for membership in the Order within a Subordinate Chapter directly under the jurisdiction of General Grand Chapter, or a Subordinate Chapter directly under a Grand Chapter under General Grand Chapter, and shall prescribe and determine the Official Dues Receipts for all members in the Order within a Subordinate Chapter directly under the jurisdiction of General Grand Chapter, or a Subordinate Chapter directly under a Grand Chapter under General Grand Chapter. (AM 1982) (AM 2009)

CHAPTER II, OFFICERS, COMMITTEES, DEPUTIES AND AMBASSADORS (AM 2003)

5. RIGHT WORTHY GRAND SECRETARY: (m), page 38 (AM 2009)

Which now reads:

(m) Act as the agent of the General Grand Chapter in the purchase and sale of officers' jewels, Rituals, blanks, books, seals, signets, receipts, forms, and other articles and supplies to be furnished to Grand Chapters, their Subordinate Chapters and Chapters under the jurisdiction of the General Grand Chapter. Act as the agent to determine the color, format, design and contents of the Official Dues Receipts for all members in the Order with the approval of the Most Worthy Grand Matron and Right Worthy Grand Trustees. (AM 2009)

Be changed to read:

(m) Act as the agent of the General Grand Chapter in the purchase and sale of officers' jewels, Rituals, blanks, books, seals, signets, receipts, forms, and other articles and supplies to be furnished to Grand Chapters, their Subordinate Chapters and Chapters under the jurisdiction of the General Grand Chapter. Act as the agent to determine the color, format, design and contents of the Official Dues Receipts for all members in the Order within a Subordinate Chapter directly under the jurisdiction of General Grand Chapter, or a Subordinate Chapter directly under a Grand Chapter under General Grand Chapter, with the approval of the Most Worthy Grand Matron and Right Worthy Grand Trustees. (AM 2009)

PARLIAMENTARY LAW ARTICLES ON THE GGC WEBSITE

Richard Ashby, Registered Procedural Parliamentarian GGC Parliamentarian PGP of Alberta

Our MWGM has very kindly instructed that a series of articles originally written to dispel some of the myths and misinformation about Parliamentary Law be made available on the GGC's Website (easternstar.org), under OES Info, then scroll down to Parliamentary Procedure. This information will present knowledge that our WM's and WP's can use to make our meetings productive, enjoyable and informative. The articles were written by myself, Richard Ashby, Registered Procedural Parliamentarian.



I have been studying Parliamentary Law for over 47 years and was the 4th to achieve that status in Canada. My brother was the 3rd! We got the exact same mark on the final test (we each got one question wrong; different questions if you were wondering). He got 3rd because his first name is closer to the beginning of the alphabet. Darn. I have helped many, many organizations with their bylaws, chaired many Annual General Meetings at the request of the President for organizations of which I was a member, just not the President. I was once appointed by court to chair an Annual General Meeting for an organization to hold their nominations and elections. A dispute was settled in court, and when asked by the Judge who they wanted to chair the "new" Annual General Meeting, both sides asked the Judge to appoint me to chair the meeting. Two hundred plus members present, 26 nominations for 18 positions. Nominations, balloting, counting of the ballots and announced the results in less than 20 minutes! Once chaired a meeting in which every single member at the meeting outranked me. Several thought to intimidate me. Didn't work. It doesn't when you know your stuff. Many more stories!! I am also the author of "Will of the Lodge," a Parliamentary Law manual specifically written for Masonic Lodges. There are a lot of myths and misinformation about Parliamentary Law. Just some of the more common myths are:

- the Chair must call for nominations three times;
- nominations need to be seconded;
- the rules are the same for all meetings;
- the absence of a quorum is okay if nobody brings it up;
- discussion first, motion later;
- seconds are really important to the point that a motion adopted by the required vote but which lacked a second is null and void;
- · a vote is needed for all reports; and
- · motion is always necessary.

The answer to some of these myths is simply NO, they are not correct. Some are conditional, and some are simply misinformation. Answers and correct information on these and many other areas of interest can be found in the articles on the GGC Website, under OES Info, then scroll down to Parliamentary Procedure. Parliamentary Law can be very confusing and bewildering. A thorough familiarity with Robert's Rules is the only way that I have found the solution to some situations. Solutions in subjects that at first appear to be completely unrelated but really do make sense when carefully examined and analyzed. I'd like to note that all the information in the articles is provided in good faith as BASIC information and does not cover all situations. There are numerous nuances that have to be considered. All the suggestions and procedures in the articles are provided in good faith as general guidelines only as not all circumstances and situations can be covered in such short articles, and suggestions contained should be used in conjunction with relevant legislation, constitutions, rules, laws, bylaws and with reasonable judgement. Parliamentary Law, when properly used, will actually save time, not waste your time; will make your meetings more productive; preserves the rights of members; protects the minority, the individual, absent members, and the collective rights of all these groups. Its object is to allow deliberation and arrive at the will of the majority in a timely manner. The end result will be that a well-run meeting will be more enjoyable for yourself and others. I hope you find the articles to be of assistance.






PRESERVATION AND CONSERVATION OF DR. ROBERT MORRIS' SIGNET

Through this program, the Grand Chapter of Illinois adopted one of our premier projects, the conservation and preservation of one of our most significant, if not unique, Eastern Star objects, the Signet owned by Dr. Robert Morris. The hand-painted animal skin on which the Signet is painted was cracking, fading and shrinking and needed to be repaired and preserved in a new airtight case.

Anne Kingery-Schwartz of Kingery Conservation, LLC of Washington, DC, was selected to undertake the project. She came highly recommended, has vast experience and is one the leading conservationists for such work. She is an objects conservator in private practice in Washington, DC, since 2011 and has worked for various Smithsonian museums, other local institutions and private clients. (Continued)

She recorded the existing conditions of the Signet before beginning conservation and provided written documentation. After carefully removing the plexi-glass covering from the case, she employed soft brushes, cosmetic sponges and a low strength vacuum to remove dust as safely as possible. Because of the warping and shrinkage of the animal skin, she carefully adhered bridges on the reverse side to stabilize it, provide a better Signet image and to hold some of the animal skin cracks together. Additionally, a new constructed airtight case was utilizing appropriate glass. The results were visually stunning and more importantly, the unique object of our Eastern Star history has been conserved and preserved for future generations.

Through this program, we hope you will adopt a project and help us to maintain this Flagship of the Eastern Star. Numerous similar projects, large and small, are featured on the Perry Belmont House Foundation website perrybelmonthouse.org.


Our MWGP was not able to cruise with us and we so missed him. From what I was told, he was doing well.



This hospital is a specialized center in preventing, researching and treating most of the different types of cancer. The Center has high technology and provides a free of charge service through the Brazilian Unified Health System. It receives more than 1,200 patients a day, coming from different parts of the country.



To offer support and accommodation primarily to members and family members from the Order of the Eastern Star who are undergoing cancer treatment, the "Home of The Stars" project was born in 2013. Recently it became a Foundation for better management.

The "Home of the Stars" started up in March 2019 at a location close to the Hospital of Love. It has 11 furnished and ready-to-stay apartments and 3 others are nearing completion. The goal is to have 24 apartments in the near future. Besides the apartments, the Home offers the patients other amenities, such as a kitchen, dining room, recreation area and garden, providing a feeling of comfort and well-being in such a delicate moment.

One set a wedding date in April 1983, just before Sister Carolyn was to be installed as WGM, and the other one chose to be married in May 1984, during the height of Sister Carolyn's preparations for the Grand Chapter Session, "Our Majestic Mountains," held in Asheville.

She taught for two years, and when kindergarten was added to public schools, the school began providing services for younger children. The school is the longest running (62 years in March) Preschool in the county. Sister Carolyn has served on the Preschool Committee continually since its establishment, and there is a scholarship named for her to provide assistance for children whose parents cannot afford the tuition. She served her church as Moderator of Presbyterian Women, Chairman of Mission Outreach and as Elder three times.

During her retirement, she was elected to the Transylvania County Board of Education and served on the County Jury Commission.

The members of Pisgah Chapter are very proud of Sister Carolyn and echo Sister Mildred Fisher's, PGM, assessment of her as "One of God's Precious Jewels."

Have you ever wondered what the life of a Grand Marshal is like? Each Grand Jurisdiction is different, and the duties of the Grand Marshal vary greatly also. Let me share my story. My name is Karla Light, and I had the great honor of serving as the Grand Marshal of the Grand Chapter of Maryland (MD) for the 2018-2019 "Stars and Stripes Forever; Let Freedom Ring!" Grand Year. Queen Esther Chapter #22 in Phoenix, Arizona (AZ), is proud to support its community crisis centers, including the Justa Center which provides life-sustaining resources, services and support to assist homeless seniors on their path to finding viable housing, and includes support services to help prevent their return to homelessness. Justa Center was established in 2006 and was named for the Canaanite woman in Matthew 15:21-28 who reached out to Jesus to heal her daughter, thus adding the Gentile as a new focus in His ministry. It is the Nation's only agency serving a hidden population of seniors experiencing homelessness, and maintains its promise to treat everyone with respect, dignity and autonomy in making their life choices. In 2006, Justa Center provided help and hope to 136 seniors and in 2019, that number surpassed 1,200, with nearly 300 being returned to housing. Justa Center continues to be the only agency to exclusively serve this growing population. In addition to providing various goods, this year Queen Esther Chapter sought the assistance of the AZ's Eastern Star Foundation, a 501(c)(3) adjunct organization of the AZ Grand Chapter, which extended a grant for \$5,000 to the Justa Center.



The check was presented by Foundation Treasurer, Sister Marsha Young, Treasurer Emeritus, to Sister Susann Holland, WM, and Brother Tony DiCola, on January 11, 2020, when Queen Esther Chapter joined Glendale Chapter #20, Glendale, to provide soup and snacks during the Glendale Glitters event. Commissioner Karen Calvert represents the 5th Maryland Congressional District for the <u>Maryland Veterans Commission</u>. She was initially appointed in February 2010 by then Governor Martin O'Malley and has been re-appointed by Governor

Larry Hogan to continue to serve on the Commission. She was also appointed to serve on the Maryland Commission for the Establishment of Women in Military Service Monument in September 2014.

A native of St. Louis, MO, she enlisted in the US Air Force on June 27,1969 immediately following her graduation from Pattonville High School. While on active duty, she became a Field Representative for the <u>Women in Military Service for America Memorial Foundation</u> encourage service women to register and become a part of the living history for women veterans.

She retired after 24 and 1/2 years of service, holding the rank of Senior Master Sergeant to take a full time position with the Memorial Foundation and she served from just before Groundbreaking until shortly after Dedication of the Memorial, which stands at the entrance to Arlington Cemetery.

Karen then went to work for the Department of Defense and ended her working career as a Protocol Officer with Bolling AFB, later re-designated as Joint Base Anacostia Bolling. She retired this time as a civilian in December 2013. She is an active member of the Order of the Eastern Star and served as Worthy Grand Matron, Grand Chapter of Maryland, 2018-2019, overseeing the "121st Stars and Stripes Forever; Let Freedom Ring!" Session in Ocean City, MD in May 2019. She has 3 children; son, Tim King, TSgt.
